Profile of Older Adults In Central Minnesota

Dear Community Leader,

Our population is aging at an unprecedented rate in Minnesota, the United States, and worldwide. As of 2020, Minnesota has a larger older adult (65+) population than school-age children (5-17 years). Between 2010 and 2030, Minnesota's older adults will double in population. In addition, by 2030, all baby boomers will be at least 65 or older, and there is projected to be little to no growth in the working-age population. Combined, these population changes are impacting healthcare and systems of support. Therefore, preparing for this demographic shift is one of the most pressing issues facing communities as it presents many opportunities and challenges.

Communities are on the front lines of this change. Community leadership can facilitate collective ownership and accountability for community-driven responses that help older adults live their best lives.

This is our newly updated, *Profile of Older Adults in Central Minnesota*. The result is an intriguing snapshot of the exceptional population changes expected due to the aging of the baby boomer generation. The information compiled will be helpful to local units of government, policymakers, service providers, and others involved in planning for or serving older adults.

The Central Minnesota Council on Aging is a regional leader in providing expertise and resources for community living. Creating Age-Friendly Communities is, and has been for over a decade, part of our organizational strategic plan. We do so by helping central Minnesota communities become more inclusive and better able to meet the needs of older residents.



Profile Highlights

- The region's senior population is expected to increase by 26.3% from 2020 to 2040.
- The region's population aged 85+ is expected to increase by 56.2% from 2020 to 2040.
 From 2030 to 2050, Minnesota's older adults aged 85+ will triple.
- 22.2% of the region's population aged 60+ live alone.
- Overall, the region has a lower caregiver ratio of 7 than the state (8).
 A third of the region, five of the 14 counties, have a higher caregiver ratio.
- 33.3% of the region's population aged 65+ have a disability.
- In Minnesota, it is projected that the number of people with Alzheimer's disease will increase by 21.2% between 2020 and 2025.
- In 2021 8.1% of the region's population aged 60+ lived in poverty.

Future Growth

Minnesota's towns and rural communities are aging faster than urban areas. The 14-county region is projected to have a higher percentage of the population aged 60+ than the state over all.

Aging in Minnesota Fact Sheet 2022

Minnesota is home to 1,306,167 older adults aged 60 years and older.

- As of 2020, Minnesota has a larger 65+ population than school-age children (5-17 years).
- From 2010 to 2030, Minnesota's older adults will double in population.
- From 2030 to 2050, Minnesota's older adults aged 85+ will triple.
- More aging women than men live alone 25% more at 65 years and 78% at 85+ years.
- Ageism plus sexism results in two times more Minnesotan older women living in poverty than men, with 17% of men relying exclusively on Social Security compared to over 33% of women.
- Minnesota's towns and rural communities are aging faster than urban areas.

Where do Minnesota's older adults live?

- Over 90% of older adults live independently in Minnesota communities. Of these, 21% receive community support and services funded through the Older Americans Act and the state legislature.
- 4.5% of Minnesota's older adults live in assisted living with an estimated consumer cost of \$1.9 billion per year based on an average out-of-pocket per person cost of \$45,000 per year.
- 2.5% of Minnesota's older adults live in long-term care at a yearly cost of \$7.9 billion per year with 69.5% public cost and 30.5% private pay with an average annual out-of-pocket cost per person of \$141,000 per year.

National life expectancy is changing from 69.84 years in 1960 to 78.99 years in 2021

- U.S. costs for long-term and community-based services and supports (LTSS) at \$426.1 billion in 2019, representing 13% of all national spending on personal health.
- Congressional Budget Office projects that LTSS spending for the 65+ population to more than double from 1.3% of the gross domestic product in 2010 to 3% in 2050.
- Nationally Medicare estimates that health issues related to **social isolation and loneliness** costs \$6.7 billion annually.
- The national impact of \$63 billion in Medicare spending due to **ageism** (the stereotyping, societal promotion of negative self-perceptions of aging, and discrimination against individuals or groups based on age) for eight health conditions cardiovascular disease, chronic respiratory disease, musculoskeletal disorders, injuries, diabetes mellitus, treatment of smoking, mental disorders, and non-communicable diseases.
 - \$11.1 billion for age discrimination
 - \$28.5 billion for negative age stereotypes
 - \$33.7 billion for negative self-perceptions of aging
 - 15.4% of the total health care spending for those 60 years and older



CMCOA REGION POPULATION IS CHANGING

The region's senior population age 60+ is expected to increase by 26.3% from 183,411 in 2020 to 231,642 in 2040. At the same time the 85+ population is also growing. In a 20 year period of time our 85+ population in Minnesota is projected to increase by nearly 50,000.

AGE 60+ AND 85+ POPULATION PROJECTIONS



2019 AGE 60+ POPULATION LIVING ALONE

In Minnesota, one in four people age 60+ live alone (25.5%). The region has a slightly lower percentage living alone (22.2%), although there is a variation by county. Two of the 14 counties are higher than the state percent and seven have a higher percent than the region.






FAMILY CAREGIVER RATIO






2021 PERSONS SERVED WITH HIGHER NEEDS



2021 Percent of LTSS By Type of Service for Persons Aged 65+







ALZHEIMER'S COMMUNITY IMPACT

As our population ages, Alzheimer's disease and related dementias will have personal, social, and budgetary impacts on all of us. Alzheimer's is the most common form of dementia. Dementia is a syndrome - a group of symptoms - which has a number of causes. It is a general term for memory loss and other cognitive abilities serious enough to interfere with daily life. It is not a part of normal aging.

In 2022, Minnesota had 163,000 caregivers provided 225 million hours of unpaid care valued at \$5.3 billion. Of the caregivers, 53.1% reported a chronic health condition and 29.8% reported depression.

2023 ALZHEIMER'S STATISTICS FOR THE U.S.A.


- One in nine people age 65 and older has Alzheimer's disease.
- 73 percent of the people with Alzheimer's are age 75 and older.
- One in three seniors die with Alzheimer's or another dementia.
- Almost two-thirds of Americans with Alzheimer's are women.
- Older Black Americans and Hispanic Americans are more likely to have Alzheimer's or other dementias than older Whites.
- In 2023, Alzheimer's and other dementias will cost the nation \$345 billion not including the value of unpaid caregiving. By 2050, the costs could rise as high as \$1 trillion.
- Between 2020 and 2030, 1.2 million additional direct care workers will be needed to care for the growing population of people living with dementia — the largest worker gap in the U.S.
- In 2022, there was an estimated 18 billion hours of unpaid care provided by family/friends/caregivers that had an estimated value of \$339.5 billion.

60+ WITH INCOME BELOW POVERTY IN 2021

The persons 60+ below poverty is the number of people aged 60+ who live below the poverty threshold. The average percentage for the 14-county service area is 8.1%, slightly above the 7.6% state average. Furthermore, nine of the fourteen counties in the service area reported higher percentages of the 60+ population below the poverty level than the Minnesota state average.

MINNESOTA HEALTH FACTOR RANKINGS

Health Factor Rankings represent what includes the health of a county. They are an estimate of the future health of counties as compared to other counties within the state.

The ranks are based on four types of measures:

- Health behaviors
- Clinical care
- Social and economic wealth
- Physical environment factors

The healthiest county in the state is ranked at #1. There are 87 counties in Minnesota.

Within the region, the county that ranked the highest is Wright (4), and the lowest is Pine (85).
